#### **Agency Updates**

BIA

- Working on tribal Unit ID updates.
- Finalized "new" Tribal Representative (TREP) position. Available in 2025. Position will be added to 2026 Federal Wildland Fire Qualifications Supplement.

Working on Unit ID/organizational code updates for Utah districts (in progress).

DoD

- Conducting comprehensive DoD Unit ID review/update/establishment and developing account management guidance for Military Departments.
- US Air Force, US Army completed.
- Working on full update of unit IDs for Navy, Marines, and guard units.

ARMY

• Review and evaluation of agency administrator position requirements based on unit complexities.

USFS

- Producing IQCS reports to determine AD vs regular employees. May establish new org code in IQCS 2.0 to better identify AD employees.
- Amphibious Water Scooper Manager (AWSM) Manual awarded of USFS responders who have been working in this capacity as THSP.
- Tentative Tribal Representative (TREP) USFS endorsement in 2026 Federal Supplement.

DOI

- Tentative Update to DOI IPQG in May/June 2025
- Updated to LEOL, Sec1 and Sec2.
- Approved to remove swift water rescue positions SWF1 and SWF2.
- Approved new sawyer qualifications intended for all-hazard and not fireline. Can get qualified under agency programs.
- New qualification: Interpreter Visitor Services. Used in situations for large crowds/events.
- Vetting of UAS positions to be updated with PMS 310-1 positions.

#### **IQCS Program Updates (Pena)**

## Staffing updates

- Jacob Smith identified as POC for IQCS organizational hierarchy, Unit IDs, IQCS 2.0 training.
- Heidi Nowack contract ending mid-August. Currently working on APIs and external application interface. Alex to continue after Heidi.
- Michael to retire 4/18. Shannon Tippett will be interim IQCS Program Manager and POC.

## IQCS current application updates

- Unit ID IQCS 2.0 will begin importing Unit IDs through API.
- Renewed People Soft. Justified contracts and approved (Shannon).

#### **IRWIN integration with WFLP:**

- May 1<sup>st</sup>, 2025 IQCS will be integrating training completion data from the WFLP and applying it to responder training records.
  - Only area of concern. In WFLP, matching EDG and IRWIN RID. Having issues with EDG API in IQCS 2.0. Unstable API with EDG for both WFLP and IQCS.
  - Training integration will include Read Only values of: Course Code, Title, Start and End Dates, Attendance in IQCS.

#### IQCS 2.0 (Skudlarek/Pena)

- Status
  - Testing areas of focus: certifying official workflow, incident qualification card, master record, user roles.
  - IQCS programmers/developers undergoing data transitioning (responder profile data/training records, etc) and addressing server requirements translated to application downtime.
  - Once IQCS 2.0 goes-live, will transition to a versioning schedule. Updates identified in spring IQCS CMB meetings will be implemented during the next version and an annual revision schedule will be established.
- Timeline Review:
  - $\circ$  Testing: agency leads 1/15/25 2/15/25 (actual testing began 2/24/25)
  - Testing: user test group 2/15/25 4/15/25 (Will update at CMB meeting)
    - Provide "user test group" names, email addresses, and organization roles (Account Managers) to Jacob for account creation.
    - IQCS development team will determine user testing date and notify agency leads.
  - o Go-Live September 2025 (recommend late fall/winter timeline)
- Agency lead testing feedback
  - BIA Concern it may not be as intuitive as made out to be and suggests a user guide or training.
  - o Pena and Joseph Bolus have ideas on user training videos.

#### **Completed Projects:**

- Remove duplicate responder email addresses Completed January 2025.
  - Added field lock to prevent users from adding an email address that already exists in the application.

#### **Business Topics:**

- Request for Change: Request from USFS to (1) add EMR license and (2) add agency codes to "state" look-up menu to designate agency-specific EMT programs.
  - Emergency Medical Responder (EMR) license:
    - Recommendation from CMB: Create a position qualification for EMR if we want to track EMR license.
  - Add agency organizations (BLM, NPS, USFS) in "State" look-up:
    - It was determined "State" look-up control table is also used in "Responder Experience". In order to maintain ease of use and not confuse users, it was determined to explore other options to accommodate the request.

## **Qualification Document Updates**

- NWCG PMS 310-1
  - January 2026 T1 and T2 C&G positions will be archived.
  - L-280 requirement for single resource boss, PMS 310-1 positions will be implemented after NWCG training pause.
  - o READ/REAF/ARCH proposed for PMS 310-1 positions.
  - o The competencies granted for S520, recommend transferring to X-520.

# Federal Wildland Fire Qualifications Supplement

- Agency updates to Federal Supplement due to Mark Skudlarek 10/1/2025. Will combine all agency updates for agency lead vetting and sharing throughout agencies for fall CMB meeting.
- o Any "new" Agency Specific Position Task Books should be developed using a word document for easier 508 compliancy. Mark Skudlarek has a template for use.
